## Terms and Definitions

Market Capitalization is the value of the fund as determined by the market price of its issued and outstanding stock. The Weighted Average Market Capitalization of a portfolio equals the average of each holding's market cap, weighted by its relative position size in the portfolio (in such a weighting scheme, larger positions have a greater influence on the calculation). Earnings growth rate is the amount of increase that a specific variable has gained within a specific period and context and is based on consensus estimates derived from FactSet as of 09/30/2024 for the 3-5 year period, and is not a measure of the Fund's future performance. Earnings Growth 3-5 Year Est. is the forecasted growth rate of a company's earnings per share. Estimated EPS Growth Rate is

not a measure of the Fund's future performance. **Price-Earnings Ratio (P/E Ratio)** is the ratio of the share of a company's stock compared to its per-share earnings. **Free cash flow** (FCF) is a measure of how much cash a business generates after accounting for capital expenditures such as buildings or equipment. **Margin of safety** is the difference between the intrinsic value of a stock and its market price.
